


Native Communities across Indian County in the United States.

Social Impact

To highlight the impacts our partner NCDFIs provide with the provision of our direct investment and development services we know that Oweesta deployed \$183.4M in fiscal year 2022—\$135.4M for small business lending, \$30.3M in housing lending, and \$17.4M in consumer lending. Our community impact evaluation showed that Oweesta's lending —in the middle of the pandemic —directly contributed to the retention of over 1,897 jobs and helped finance 685 existing small micro-businesses. COVID-19, NCDFIs portfolio even created 119 small businesses, 513 new jobs, and 114 homebuyers. In addition, Native CDFIs in our portfolio provided training or TΑ to 5,079 individuals. Subsequently, we know that the 3,583 clients we provided development services for the last year reached 8,548 individuals with over 80% of these individuals in high poverty areas.
